## PAKISTAN RRHABILITATION ORDINANCE, 1948

. (Rehabilitation Board for Capital of Federation)

No. 41 (20)/49-P., 8th December 1949.—In exercise of the powers conferred by section 12 of the Pakistan Rehabilitation Ordinance, 1948 (XIX of 1948), the Central Government is pleased to set up for the Capital of the Federation a Rehabilitation Board for the allotment of such evacuee property as does not come within the jurisdiction of the Rehabilitation Board for Sind and the Capital of the Federation and for the rehabilitation of the social and economic life of the Capital of the Federation, and to invest it with all the powers mentioned in section 6 of the said Ordinance.

## PAKISTAN (DEALINGS IN IMMOVABLE EVACUEE . PROPERTY) ORDINANCE, 1949

(Extension of operation)

No. F. 28 (33)/49-P., 8th December 1949.—In exercise of the powers conferred by subsection (4) of section 1 of The Pakistan (Dealings in Immovable Evacuee Property) Ordinance, 1949 (XI of 1949), the Central Government, in continuation of this Ministry's Notification No. F. 28 (33)/49-P., dated the 22nd November, 1949, is pleased to direct that the said Ordinance shall remain in force in West Punjab, the North-West Frontier Province, Sind, Baluchistan, the Capital of the Federation and the Acceding States for a further period of one month beginning from the eleventh day of December, 1949.

## POST OFFICE RULES, 1933

(Amendment)

No. D. 37-5/49., 19th December 1949.—In exercise of the powers conferred by the Post Office, Act, 1898, (VI of 1898), the Central Government is pleased to direct that the following further amendments shall be made in Post Office Rules, 1933, namely:—

In rule 183 of the said Rules after clause (gg) the following new

clause (hh) may be inserted:

"(hh) The following officers of the Government of India provided that the articles posted by them relate solely to the business of their Government, viz., the High Commissioner for India in Pakistan, the Dy. High Commissioner for India in Pakistan, Lahore and Dacca, the Permit Officer for India at Karachi, the Indian Government Trade Commissioner at Karachi and the Liaison Officer for India, Karachi."
