

It is hereby enacted as follows :—

1. *Short title and commencement.*—(1) This Act may be called the Royal Pakistan Navy (Extension of Service) Act, 1950.

(2) It shall come into force at once.

2. *Extension of service where term of service has expired.*—Until such date as may be notified in this behalf by the Central Government, any person enrolled for service in the Royal Pakistan Navy who, by reason of the expiry of the term for which he was engaged to serve when so enrolled is no longer liable for service shall, notwithstanding such expiry, continue to be enrolled for service and to be liable for service in the Royal Pakistan Navy until he is discharged by the order of the Officer Commanding the Royal Pakistan Navy :

Provided that the period for which the service of any such person is extended under this section shall not exceed five years from the day on which his service would otherwise have terminated.

3. *Repeal of Act III of 1940.*—The Royal Pakistan Navy (Extension of Service) Act, 1940 (III of 1940) is hereby repealed.

### PAKISTAN (DEALINGS IN IMMOVABLE EVACUEE PROPERTY) ORDINANCE, 1949

(Period extended)

No. F. 28 (33)/49-P., 10th March, 1950.—In exercise of the powers conferred by subsection (4) of section 1 of the Pakistan (Dealings in Immovable Evacuee Property) Ordinance, 1949 (XI of 1949) the Central Government, in continuation of this Ministry's Notification No. F. 28 (33)/49-P, dated the 10th January, 1950, is pleased to direct that the said Ordinance shall remain in force in Baluchistan for a further period of two months beginning from the eleventh day of March, 1950.

### ESSENTIAL SUPPLIES (TEMPORARY POWERS) SUGAR AND SUGAR PRODUCTS CONTROL ORDER, 1948

(Amendment)

No. PY-16 (47), 28th January 1950.—In exercise of the powers conferred by sections 3 and 4 of the Essential Supplies (Temporary Powers) Act, 1946 (XXIV of 1946) the Government of Pakistan in the Ministry of Food and Agriculture is pleased to direct that the following amendment shall be made in the Sugar and Sugar Products Control Order, 1948, issued under this Ministry's Notification No. PY-18/48, dated the 28th February, 1948, namely :—

For clause 8 (1) of the aforesaid Order, the following clause shall be substituted, namely :—

"8 (1) No sugar shall be transported, or offered or accepted for transport, whether by rail, road, water or any other means of transport and whether by a railway servant, common carrier or other person except under and in accordance with the terms of :—"
