AN ACT FURTHER TO AMEND THE INDIAN INDEPENDENCE ACT, 1947.

(10 and 11 Geo. 6, Ch. 30)

Whereas it is expedient further to amend the Indian Independence Act, 1947, for the purposes hereinafter appearing;

It is hereby enacted as follows :-

- Short title and commencement .- (1) This Act may be called the Indian Independence (Amendment) Act, 1949.
 - (2) It shall come into force at once.

2. Amendment of subsection (3) of section 19 of the Indian Independence Act, 1947.—After the proviso to subsection (3) of section 19 of the Indian Independence Act, 1947, the following further proviso shall be inesrted:-

"Provided further that nothing in this subsection shall be construed as preventing any increase or reduction in the number of seats or any redistribution of seats in the Constituent Assembly for Pakistan, and the powers of the said Assembly shall extend to and be deemed always to have extended to the making of provision therefor."
